What is the “Financial Leadership for Water Utility Governing Boards” Program?

A series of small participatory workshops in which utility finance specialists will work with local boards to expand their understanding of their financial management obligations and responsibilities. Workshop topics will include:

- Legal financial oversight responsibilities
- Rates and charges
- Capital planning
- Finance tools – capital reserve funds, cash flow projection models

Why attend?

Recent developments across the country have reinforced the importance of financial management in assuring the ability of utilities, especially small ones, to provide high quality, safe, environmentally sound services to their customers. Assessing and strengthening financial capacity is now a federal and state regulatory requirement.

Who can attend?

Water and wastewater utility governing boards, municipal councils, county commissions, sanitary district boards, and water and sewer authority boards. Priority is given to smaller systems that are facing financial difficulty. The majority of the board must attend.

Nominal fees will be charged. Funding assistance is available to the Boards of smaller systems (serving less than 10,000).
